UHE-1001/3/2022-HTE-DHTE dated 12-07-2024 and concurrence of the Department of Personnel (DP), Government of Manipur vide U.O. No. 7/2024-2025/DP dated 09-07-2024 for the declaration of results for direct recruitment approved under resolution 11/13/6.11.2024 of the 13th meeting of the Syndicate held on 6th Nov 2024 and on completion of the verification of the Offer form submitted, Shri Khoirom Chitaranjan Singh is hereby appointed to the post of Assistant Professor(OBC-M) in Philosophy under the existing terms and conditions of service as may be decided from time to time. He is hereby directed to submit joining letter within 10 (ten) days from the date of issue of this order.

- 2. He will be on probation for a period of 1 (one) year extendable by another year.
- 3. He will be covered by the New Pension Scheme as per the Govt. of Manipur.
- 4. He will be paid a starting pay in the scale of Rs. 15,600-39,100/- + AGP Rs. 6000/- (prerevised) plus such allowances as may be admissible to the members of staff of this University from time to time.
- 5. Other terms and conditions of the appointment shall be governed by the terms of contract which he executed with the Dhanamanjuri University.
- 6. He is expected to take part in teaching and research programme of the Constituent Colleges of the University besides such other works as may be assigned to him from time to time. His services is transferable within the Constituent Colleges of the Dhanamanjuri University.
- 7. He is required to report to the Principal, DM College of Arts, DMU.
