Recovery of Allowances and Increment Drawn During Study Leave

No. 15/10/2026-DMU/SLF /1693 Whereas, the conditions governing the admissibility and drawal of specific allowances and benefits during the period of Study Leave have been prescribed vide Finance Department, Government of Manipur O.M. No. 12/1/2005-FD9(PIC), dated 7 September 2007, and the relevant provisions are as follows:

1. **Transport Allowance (TA):** No Transport Allowance shall be admissible or drawn during the period of Study Leave.
2. **Increment:** No increment shall accrue during the period of Study Leave, and the increment shall become payable prospectively only upon resumption of duty, in accordance with the applicable rules.

Whereas, the following faculty members were **granted Study Leave** during which the aforesaid provisions relating to admissibility and payment of allowances and accrual of increment were not inadvertently adhered to whereby **resulting in drawal of amounts not admissible under the applicable rules;**

Now, therefore, in view of the aforesaid provisions and in order to ensure compliance with the applicable financial rules, instructions and Government directives, the **excess amounts drawn by the concerned faculty members, as detailed against their respective names in Table-A, shall be recovered from their salaries in suitable instalments as indicated therein.**

In respect of all the faculty members listed in the table, except Dr. Varekan Keishing, the respective salary amounts after deduction of the recoverable amount shall be worked out, and the figures so arrived at shall be submitted to the Government for sanction.

With regard to Dr. Varekan Keishing, the amount recovered shall be credited/deposited under the relevant Government Head of Account (HoA), as applicable.

This is issued with the approval of the competent authority.
