4. The term of office of the members of the Syndicate shall commence from the date of appointment or nomination as the case may be.
5. Registrar, Dhanamanjuri University shall act as the Secretary of the Syndicate (u/s 13 (6) of the DMU Act, 2017.
6. Ten members of the Syndicate shall form the quorum.
