About Dhanamanjuri University

Dhanamanjuri University (DM University) has come into existence during the current year under "The Dhanamanjuri University Act, 2017" which came into force on the 6th of April, 2018 through a notification in Manipur Gazette published by the Department of Higher and Technical Education, Government of Manipur. "The Dhanamanjuri University Bill, 2017" was passed on the floor of Manipur Legislative Assembly on 3rd August, 2017. The University was established under the National Scheme of Rashtriya Uchchatar Shiksha Abhiyan (RUSA).

Dhanamanjuri University is a long-cherished dream of our founding fathers and Maharani Dhanamanjuri, the mother spirit in the birth of this seat of learning, translated into action. Manipur, an ancient Kingdom, had a composite traditional system of education in the field of warfare, martial arts, games and sports, culture and many other schools of thought training the people in various professional activities in ancient forms. The people have carried down this legacy of quest for knowledge and civilized existence since time immemorial. Ancient works of knowledge in the original scripts of Manipur stand as testimony to the nurturing of the idea of a University in the minds of our forefathers and foremothers. The state has celebrated the tradition of a purely intellectual pursuit which conserves the original ethos of the land and its people while receptive with an open mind to change in course of time.

The University was established under the National Scheme of Rashtriya Uchchatar Shiksha Abhiyan (RUSA) as fulfilment of one of its primary components i.e., to convert colleges to cluster Universities. Maharani Dhanamanjuri gifted us Dhanamanjuri College and in recognition of her contribution to the development of Higher Education, the university is named after Maharani Dhanamanjuri. The University is built up of Five (5) Constituent Colleges viz. DM College of Science, DM College of Arts, DM College of Commerce, G.P. Women's College and LMS Law College, all of which occupy common, adjoining or neighbouring physical spaces.

DM University at present is functioning from DM College campus situated in the heart of Imphal city and the campus is bounded by National Highway No.2 in the East, Thangmeiband road in the West and North, and the Naga River in the South. Ghanapriya Women's College is located at the South West of Kangla, the Old palace of Manipur near the Raj Bhavan and LMS Law College is located just in-front of the DM Campus crossing the National Highway No.2

COURSE STRUCTURE:

- (i) The University follows Semester-Scheme system. There shall be four (4) Semesters with University Examination at the end of each Semester.
- (ii) Departmental level Internal Assessment/Seminar/Viva Voce shall be conducted under the strict guidelines of Dhanamanjuri University Regulations.
- (iii) A student is required to attend at least 75% of the Lectures delivered including practical (for students having practical) for appearing in the Semester Examinations as a regular candidate

ADMISSION PROCESS:

The Admission Committee under the chairmanship of Vice-chancellor, DMU deals with all matters relating to the admission process. The decision of the Committee in this regard shall be final and binding.

HOW TO APPLY:

Prospectus along with application forms can be downloaded from the university website – www.dmu.ac.in . Duly filled in application forms along with relevant documents can be submitted at the Office Counter, Dhanamanjuri University, DM College of Arts Complex, Administrative Block, Ground Floor. Complete application should be accompanied by proof of Online transaction of ₹300/- for UR/OBC and ₹200/- for ST/SC/DAPs payable to Dhanamanjuri University, ICICI Bank(Details are given in the Mode of Admission Fee Payment). Incomplete applications or applications received after the last date shall be summarily rejected.

Students willing to apply in more than one subject should submit separate Application Forms and appear in the separate Entrance Examination.

ELIGIBILITY:

Eligibility Criteria for M.Sc./M.A./M.Com./M.P.E.S.

- a. Candidates seeking admission to M.Sc./M.A./M.Com. should have passed B.Sc./B.A./B. Com. (three years undergraduate programme) examination or equivalent thereto from any recognized Institution/University recognized by the UGC with 50% marks in the Honours/Major subjects for unreserved category and 45% marks in the Honours/Major subjects for ST/SC/OBC/DAP/Sports candidates of Eminence/Children of Ex-Servicemen.
- b. Candidates who do not offer honours should offer the relevant subject as one of the electives in the undergraduate level and should secure 50% marks in aggregate and 50% marks in the subject concerned for unreserved category and 45% marks in aggregate and 45% marks in the subject concerned for ST/SC/ OBC/DAP/Sports candidates of eminence/Children of Ex-Servicemen.
- c. An Honours graduate may apply for admission to M.Sc./M.A./M.Com. programme in a subject which he/she offered as an elective/subsidiary subject in the undergraduate level. However, the candidate shall be treated as Non-Honours/Non-Major graduate.

- d. Non-Honours/Non-Major graduates seeking admission to M.Sc. Chemistry should have offered Physics or Mathematics as one of the elective subjects in B.Sc. (three years undergraduate programme).
- e. Non-Honours/Non-Major graduates seeking admission to M.Sc. Physics should have offered Mathematics as one of the elective subjects in B.Sc. (three years undergraduate programme).
- f. Candidates with Physics Honours in B.Sc. (three years undergraduate programme) or Non-Honours/Non-Major graduates who offered Physics as one of the elective subjects in B.Sc. (three years undergraduate programme) can also apply for admission to M.Sc. Electronics.
- g. Candidates seeking admission to M.Sc. Environmental Science should have passed B.Sc. (three years undergraduate programme) examination with honours in any subject or B.Sc. in Environmental Science or equivalent thereto from any recognized Institution/University recognized by the UGC.
- h. Candidates seeking admission to M.P.E.S. should have passed B.Sc. Physical Education, Health Education and Sports (3 years)/B.P.E.S. (3 years)/B.P.Ed. (4 years Integrated course)/B.P.Ed. (2 years course after graduation) from any recognized Institution/University recognized by the UGC with 50% marks in aggregate for unreserved category and 45% marks in aggregate for ST/SC/OBC/DAP/Sports candidates of Eminence/Children of Ex-Servicemen.

Eligibility for Admission to LL.M.:

- i. A graduate in law from any University recognized by the Central and State Law or deemed University or a Foreign University recognized as being at par with an Indian University shall be eligible to apply for admission to the LL.M. 1st Semester provided, he/she has obtained a minimum aggregate of 50% marks computed on the basis of performance of all the LL.B. degree examinations.
- j. The admission to LL.M. 1st Semester shall be selected on merit, based on a combined assessment of; (a) the performance at a written test conducted for the purpose, (b) the past academic record of LL.B. degree and (c) the performance in viva-voce. The components of (a) (b) and (c) shall have 40%, 40% and 20% respectively.

MODE OF SELECTION:

a. Selection will be made purely on the basis of total marks obtained in the Written Entrance Examination and weightages* and subject to the verification of original documents.

* Weightages:

- Three marks shall be given to those students who have offered Honours or Major Subject in BA/B.Sc/B.P.E.S./B.Com/LLB.
- Two marks shall be given to those students who have participated in NSS camp/passed NCC (C certificate) Course/ or participated in any Swachh Bharat Programme organised by the concerned Institute/College.
- b. Scheme of written Entrance Examination (M.A./M.Sc./M.P.E.S./M.Com./LLM)
- Multiple Choice Question type of 2 marks each.
- Full Marks: 100
- Number of Question:50
- Syllabus of the written Entrance Examination shall be of Degree level of the concerned subject.
- Duration of written Entrance Examination will be of 2 hrs only.
- Candidates should bring the Admit Card on the day of Entrance examination.
- No candidate will be allowed to sit for written Entrance Examination without Admit Card.
- c. The Admission Committee shall decide the minimum marks for provisional eligibility for admission to PG Course as per the overall result of the Entrance Examination of that particular subject.
- d. Candidates securing below the minimum eligible marks in the Entrance Examination shall not be allowed admission even in the eventuality of vacancies, however, the Admission Committee reserves the right for final decision.
- e. The Admission Committee reserves the right for rechecking/re-evaluation of Answer Scripts as and when required.

f. **FOR M.P.E.S:**

Scheme of Examination shall be:

Written Examination : 50 marks (25 questions of 2marks each)

General Fitness Test : 40 marks

Aptitude Test: 10 marks

Bonus marks will be awarded to the following categories of Sports persons:

a. International Level : 10 marksb. National level : 5 marksc. State level : 2 marks

All others criteria mentioned above will also apply for M.P.E.S. too.

- i. One self-attested photocopy of supporting document of Ex-servicemen parent for candidates applying under Ex-servicemen category.
- j. One self attested photocopy of AADHAAR card.
- k. One self-attested fitness certificate issued by the competent authority for admission to M.P.E.S.

*The applicants should ensure fulfilment of the following eligibility condition:

- use of the prescribed Application form,
- completeness of the Application form in all respects,
- > submission of duly filled in Application form within the stipulated time,
- safe recording of Application form serial number for future reference

RESERVATION:

- Out of the available intake capacity of seats, 31% will be reserved for ST, 17% for OBC, and 2% for SC.
- Reservation of candidates belonging to Differently Able Persons (DAP), Sports Persons of Eminence (National/International Players), Children of Exservicemen shall be on horizontal basis, i.e. their reservation shall be within their original categories (for MA/M. Sc. /M. Com only)
- The University entertains no other reservation/quota systems other than those officially applicable as per rules.

DECLARATION OF TEST RESULT:

The final result of the written Entrance Examination for allowing admission in the pattern of the Overall Merit List, Selected List and waiting list.

All admissions should be taken within the stipulated duration. No candidate once selected for admission shall be given a second chance.

Vacancies arising after the First-List shall be filled up by merit from the Wait-List. There will be no second Wait-lists.
