Annexure-I

Eligibility criteria for admission to the Ph.D. programme

1. Candidates who have completed:

A 1-year/2-semester Master's degree programme after a 4-year/8-semester Bachelor's degree programme or a 2-year/4-semester Master's degree programme after a 3-year Bachelor's degree programme or qualifications declared equivalent to the Master's degree by the corresponding statutory regulatory body of Dhanamanjuri University and approved by Board of Studies for Schools (BSS), with at least 55% marks in aggregate or its equivalent grade in a point scale wherever grading system is followed.

Or

Equivalent qualification from a foreign educational institution accredited by an assessment & accreditation agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country to assess, accredit or assure quality and standards of the educational institution.

Or

A 4-year/8-semester Bachelor's degree programme with a minimum of 75% marks in aggregate or equivalent grade on a point scale wherever the grading system is followed.

2. Candidates who have completed the M.Phil. programme with at least 55% marks in aggregate or its equivalent grade in a point scale wherever grading system is followed or equivalent qualification from a foreign educational institution accredited by an assessment & accreditation agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country to assess, accredit or assure quality and standards of educational institutions, shall be eligible for admission to the Ph.D. programme.
3. An in-service full-time regular teacher/staff of the Dhanamanjuri University, Manipur may be given direct registration during the normal admission process without taking the entrance test, subject to presentation of seminar and approval thereof with the permission from the competent authority such as No Objection Certificate (NOC)/Release Order etc. However, they shall be treated as part-time and supernumerary/extra-numerary Ph.D. student.
4. If a candidate is a regular employee in any organization, he/she is required to submit a "No Objection Certificate" issued by that organization where the candidate is employed, which states that:
- The candidate is permitted to pursue Ph.D. programme.
 - His/Her official duty permits him/her to devote sufficient time for research.
 - If required, he/she will be relieved from the duty to complete the course.

Note:

- 1) A relaxation of 5% marks or its equivalent grade for those candidates belonging to SC/ST/OBC (non-creamy layer)/Differently-Abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the UGC from time to time.
- 2) Reservation of seats for SC/ST/OBC/PWD/EWS shall be determined as per the norms of the Government of Manipur.
- 3) Candidates in their final semester of the qualifying examination/degree are also eligible to apply subject to the submission/production of the required documents within 45 (forty-five) days from the date of the entrance test.
