NOTIFICATION

Imphal, the 30th October, 2017

No. 2/52/2017-Leg/L: The following Act of the Legislature, Manipur which received assent of the Governor of Manipur on October 25, 2017 is hereby published in the Official Gazette:

THE DHANAMANJURI UNIVERSITY ACT, 2017
(MANIPUR ACT NO. 9 OF 2017)

AN

ACT

to establish and incorporate a teaching and affiliating State University at Imphal and to provide for matters connected therewith or incidental thereto;

WHEREAS the Under-Graduate and Post-Graduate courses of the Degree Colleges including some professional Colleges in Manipur are affiliated to Manipur University, and consequently the courses in their Under-Graduate and Post-Graduate programmes are organized on the lines of the Manipur University.

AND WHEREAS Dhanamanjuri College of Science, Dhanamanjuri College of Arts, Dhanamanjuri College of Commerce, L M S Law College and G.P. Women's College occupy common, adjoining or neighbouring physical spaces.

AND WHEREAS it is considered necessary to set up a separate University in the State of Manipur so that higher education in the State may develop to meet the requirement of qualified human resources of the State in particular and the region in general.

Be it enacted by the Legislature of Manipur in the Sixty- eighth Year of the Republic of India as follows:-

Short title and
Commencement

1. (1) This Act may be called the Dhanamanjuri University Act, 2017.
- (2) It shall come into force on such date as the State Government may, by notification in the Official Gazette, appoint and different dates may be appointed for different provisions of this Act.

Effect of
establishment
of the
University

2. (1) On and from the date on which this Act comes into force in respect of undergraduate and post-graduate Colleges and in professional Colleges, the University as constituted under the Manipur University Act, 2005 (Central Act No. 54 of 2005) shall cease to exercise jurisdiction over such educational institutions established and maintained by the Government of Manipur, and such Degree

Colleges as are recognized by that University, after following due process; and the Statutes, Ordinances, and Regulations of the Manipur University shall not be operative in so far as they relate to such institutions, after following due process, and the Dhanamanjuri University shall exercise authority and jurisdiction over all such educational institutions from the aforesaid date.

(2) On and from the date on which this Act comes into force in respect of post-graduate education and research, the Manipur University as constituted under the Manipur University Act, 2005 shall cease to exercise jurisdiction, after due process, over the State Government Colleges of Dhanamanjuri College of Science, Dhanamanjuri College of Arts, Dhanamanjuri College of Commerce, G P. Women's College and LMS Law College, all located at Imphal:

Provided that subsequent creation of posts, both for teaching and non-teaching faculties, in the Dhanamanjuri University shall be made by the appropriate authority of the University.

(3) The State Government of Manipur may make provisions for the creation of the essential new posts as may be required for the newly established Dhanamanjuri University.

(4) The assets and liabilities, all properties both moveable and immoveable including land, buildings thereupon, infrastructure, etc. along with rights of the Dhanamanjuri College of Science, Dhanamanjuri College of Arts, Dhanamanjuri College of Commerce, G P. Women's College and LMS Law College shall be deemed to be transferred to the Dhanamanjuri University, after due process, upon the enactment of this Act from the date this Act comes into force. Provided that such transfer of the assets, liabilities and rights of the cluster of Colleges constituting Dhanamanjuri University shall be initially made under the supervision of the Department of Higher and Technical Education and other concerned Departments of the Government of Manipur.

Definitions

3. In this Act, unless there is anything repugnant in the subject or context-

- a) "Academic Council" means the Academic Council of the University;
- b) "College" means a constituent College of the University or a College affiliated to the University;
- c) "Constituent College" means Dhanamanjuri College of Science, Dhanamanjuri College of Arts, Dhanamanjuri College of Commerce, G. P. Women's College and L.M.S. Law College located at Imphal;
- d) "employee" means every person employed in the University;
- e) "Government" means the Government of Manipur;
- f) "Hostel" means a unit of residence, by whatever name called, for students of the University provided, maintained or recognized by the University;

- g) "prescribed" means prescribed by the Statutes, Ordinances or Regulations made under this Act;
- h) "Professional College" means a College imparting instructions in the professional subjects namely, Law, Medicine, Engineering, Technology, Agriculture, Veterinary, and such other subjects as may be prescribed from time to time as professional subjects under the Statutes;
- i) "Recognized Institution" means an institution of higher learning maintained, affiliated, recognized, or associated with the University;
- j) "Recognized teacher" means such a person as is recognized by the University for the purpose of imparting instruction in a college or an institution admitted to the privileges of the University;
- k) "Registered Graduate" means a graduate registered under the provisions of this Act;
- l) "Senate" means the Senate of the University;
- m) "School of Studies" means a School of Studies of the University;
- n) "Syndicate" means the Syndicate of the University;
- o) "Statutes" "Ordinances" and "Regulations" means respectively the Statutes, Ordinances and Regulations of the University made under this Act;
- p) "Teacher of the University" means a Professor, Associate Professor, Assistant Professor and such other person as may be appointed for imparting instruction or conducting research in the University or in any College or institution maintained by the University and is designated as such by Ordinance made under this Act; and
- q) "University" means the University established and incorporated as a University under this Act.

- The University** 4. (1) A University shall be constituted in the State of Manipur by the name of "Dhanamanjuri University".
- (2) The first Chancellor and the first Vice-Chancellor of the University and the first members of the Senate, the Syndicate, the Academic Council and the College Development Council and all persons who may hereafter become such officers or members, so long as they continue to hold such office or membership, are hereby deemed to have constituted a body corporate by the name of "Dhanamanjuri University."
- (3) The University shall have perpetual succession and a common seal and may sue and be sued by the said name.
- (4) On the establishment of the University under the Act, the University shall strictly adhere to the rules and regulations, norms and standards,

procedures and guidelines of the University Grants Commission (UGC) in respect of its establishment and maintenance of standards in Universities and any such rules and regulation, norms and standards, procedures and guidelines of the UGC issued from time to time.

(5) The headquarters of University shall be at Imphal.

**Mandatory
Assessment &
Accreditation**

5. The University shall seek and obtain accreditation as mandated under the University Grants Commission (Mandatory Assessment and Accreditation of Higher Educational Institutions) Regulations, 2012, from relevant national and international accreditation bodies like the National Assessment and Accreditation Council, the National Board of Accreditation or any other regulatory body as may be established by the Government from time to time and shall similarly seek international accreditation to enhance the standard of higher education in the University.

Objects

6. The objects of the University shall be to disseminate advanced knowledge, wisdom and understanding by teaching and research and by the example and influence of its corporate life and, in particular, to promote the objects set out in the First Schedule to this Act.

Open to all

7. The University shall be opened to all persons irrespective of sex, race, creed, class or domicile and, it shall not be lawful for the University to adopt or impose any test whatsoever of religious belief or profession in order to entitle a person to be admitted thereto as a teacher or student, or to hold any office therein or to graduate there at, or to enjoy or exercise any privilege thereof, except where such test is specially prescribed by the Statutes or in respect of any particular benefaction accepted by the University or when such test is made a condition thereof by any testamentary or other instrument creating such benefaction.

**Reservation
Policy of the
University**

8. The University shall follow and strictly implement the Reservation Policy and Rules of the Government as may be laid down by the Government from time to time. Such reservation shall apply to admission of students and appointment to all posts including those included within the category of the Officers of the University and all Teaching and Non-Teaching posts but shall exclude such ex-officio positions like the Chancellor of the University or any such other positions as may be held in similar nature.

**Existing five
constituent
colleges**

9. From the date of coming into force of this Act, the existing five colleges, viz, Dhanamanjuri College of Science, Dhanamanjuri College of Arts, Dhanamanjuri College of Commerce, G. P. Women's College and L.M.S. Law College shall be constituent colleges of the Dhanamanjuri University. The Post Graduate level Departments shall however, come under the jurisdiction of the University from the date of coming into force of this Act.

**Powers of the
University**

10. The University shall have the following powers, namely:
- (a) to provide for instruction including the method of correspondence courses in such branches of learning as the University may from time to time determine, and to make provision for research and for the advancement

and dissemination of knowledge; and to provide the necessary expertise for the development of the State and the region;

- (b) to establish within the State of Manipur or outside that State such Special Centres and Specialized Laboratories and such other units for research and instruction as are necessary for the furtherance of its objects, as may be permissible within the rules and regulations of the UGC as may be amended from time to time;
- (c) to organize and undertake extra-mural teaching and extension services, and to formulate and implement plans regarding the interaction of the University with the community around it;
- (d) to hold examinations and grant diplomas and certificates to and confer degrees and other academic distinctions on, persons, and to withdraw any such diplomas, certificate, degrees or other academic distinctions for good and sufficient cause;
- (e) to confer honorary degrees or other academic distinctions in the manner laid down in the Statutes;
- (f) to create such teaching, administrative and other posts as the University may deem necessary, from time to time, and to make appointments thereto;
- (g) to appoint or recognize persons as Professors, Associate Professors or Assistant Professors or otherwise as teachers of the University;
- (h) to institute and award Fellowships, Scholarships, Exhibitions and Prizes;
- (i) to establish and maintain Colleges and hostels, to recognize, affiliate, guide, supervise and control Degree and Post Graduate Colleges, Professional Colleges and hostels not maintained by the University and other accommodation for students not maintained by the University, and to withdraw any such recognition or affiliation;
- (j) to regulate and enforce discipline among students and employees of the University and to take such disciplinary measures in this regard as may be deemed necessary;
- (k) to make arrangements for promoting the health and general welfare of students and employees of the University;
- (l) to determine and provide for examinations for admission into the University;
- (m) to recognize for any purpose, either in whole or in part, any institution or members or students thereof on such terms and conditions as may, from time to time, be prescribed and to withdraw such recognition;
- (n) to co-operate with any other University or authority or association or public or private body having in view the promotion of purposes and objects similar to those of the University for such purposes as may be agreed upon, on such terms and conditions as may, from time to time, be prescribed; and in particular, to maintain a special relationship with the Manipur University & other similar institutions as a major resource for the development of faculty and for inter-University partnership in research on problems of regional, national or international importance;

- (o) to enter into any agreement for the incorporation in the University of any other institution and for taking over its rights, properties and liabilities and for any purpose not repugnant to this Act;
- (p) to demand and receive payment of such fees and other shares as may be prescribed from time to time;
- (q) to receive grants from the Government and donations from private individuals or associations for specific or general purposes, to acquire, hold, manage and dispose of any property, movable or immovable including trust or endowed property within or outside the State of Manipur, for the purposes or objects of the University, and to invest funds in such manner as the University thinks fit;
- (r) to make provision for research and advisory service; and for that purpose, to enter into such arrangement with other institutions or bodies as the University may deem necessary;
- (s) to provide for the printing, reproduction and publication of research and other work which may be issued by the University;
- (t) to borrow, with the previous written approval of the State Government, on the security of the University property, money, for the purposes of the University;
- (u) to constitute for the benefit of its officers and employees, pensions and provident funds as it may deem fit in such manner and subject to such conditions as may be prescribed; and
- (v) to do all such things as may be necessary, incidental or conducive to the attainment of all or any of the objects of the University.

**Jurisdiction of
the University**

11. (1) The jurisdiction of the University shall extend to the entire territory of the State of Manipur.
- (2) Where any institution or body outside the State of Manipur seeks recognition or affiliation from the University or where the University establishes and maintains any institutions or body outside the State of Manipur, provided the same is within the rules and regulations of the UGC as may be amended from time to time, then the powers and jurisdiction of the University shall extend to such institution or body subject to:-
 - (i) the laws in force in the State within which; and
 - (ii) the rules and regulations of the University, if any, within whose jurisdiction, the said institution or body is situated.

**Chancellor of
the University**

12. (1) The Governor of Manipur shall be the Chancellor of the University.
- (2) The Chancellor may, from time to time, appoint one or more persons to review the work and progress of the University and to submit a report thereon; and upon receipt of that report, the Chancellor may, after obtaining the views of the Syndicate thereon, take such action and issue such directions as he considers necessary in respect of any of the matters dealt with in the report and the University shall be bound to comply with such directions.

- (3) The Chancellor shall also have the right to cause an inspection to be made by such person or persons as he may direct of the University, its buildings, laboratories and equipment and of any institution maintained by the University and also of the examinations, teaching and other work conducted or done by the University and to cause an inquiry to be made in respect of any matter connected with the University.
- (4) The Chancellor shall in every case give notice to the University of his intention to cause an inspection of inquiry to be made, and the University shall be entitled to appoint a representative who shall have the right to be present and be heard at such inspection or inquiry.
- (5) The Chancellor may address the Vice-Chancellor with reference to the result of such inspection and inquiry, and the Vice-Chancellor shall communicate to the Syndicate the views of the Chancellor with such advice as the Chancellor may offer upon the action to be taken thereon.
- (6) The Syndicate shall communicate through the Vice-Chancellor to the Chancellor such action, if any, as it is proposed to take or has been taken upon the result of such inspection or inquiry.
- (7) Where the Syndicate does not, within a reasonable time, take action to the satisfaction of the Chancellor, the Chancellor may, after considering any explanation furnished or representation made by the Syndicate, issue such direction as he may think fit and the Syndicate shall be bound to comply with such directions.
- (8) The Chancellor may by order in writing annul any proceeding of the University which is not in conformity with this Act, the Statutes or the Ordinances:

Provided that before making any such order, the Chancellor shall call upon the University to show cause why such an order should not be made, and shall consider the cause if any is shown within a reasonable time.
- (9) The Chancellor shall also have such other powers as may be prescribed by the Statutes.

**Officers of the
University**

13. (1) The Chancellor shall be the Head of the University and President of the Senate.
- (2) The Chancellor shall, if present, preside at the Convocation of the University for conferring degrees and all meetings of the Senate.
- (3) There shall be a Vice-Chancellor, appointed in the manner provided for in section 14, who shall be the principal executive and academic officer of the University and ex-officio Chairman of the Syndicate, the Academic Council and Finance Committee and he shall, in the absence of the Chancellor preside at any Convocation for conferring degrees and also at any meeting of the Senate.
- (4) There shall be a Pro Vice-Chancellor who shall be appointed in such manner and with such powers and duties as may be prescribed by the Statutes.

- (5) There shall be a Dean for each School of Study who shall be appointed in such manner and with such powers and duties as may be prescribed by the Statutes.
- (6) There shall be a Registrar who shall act as Secretary of the Senate, the Syndicate and the Academic Council and he shall be appointed in such manner and with such powers and duties as may be prescribed by the Statutes.
- (7) There shall be a Finance Officer who shall be the Secretary of the Finance Committee and who shall exercise such powers and perform such duties as may be prescribed by the Statutes.
- (8) There shall be such other officers as provided for in the Statutes.

**Vice-
Chancellor
of the
University**

14. (1) The Vice-Chancellor shall be appointed by the Chancellor from a panel of not less than three persons who shall be recommended by a Committee consisting of three members:

Provided that if the Chancellor does not approve of any of the persons so recommended, he may call for fresh recommendations.

- (2) The Committee under sub-section (1) of this section shall consist of a member nominated by the Syndicate, a member nominated by the Chancellor and a member nominated by the University Grants Commission:

Provided that the member nominated by the Syndicate shall be a person who is not connected with the affairs of the University.

Provided further that the first Vice-Chancellor, who shall hold office for a term of 3(three) years, shall be appointed by the Chancellor:

Provided also that till the appointment of the first Vice-Chancellor, the Administrative Secretary in-charge of the Department of Higher & Technical Education, Government of Manipur shall be the ex-officio Vice-Chancellor of the Dhanamanjuri University for a term not exceeding three years.

- (3) The Vice-Chancellor shall be a whole-time salaried officer of the University.
- (4) The Vice-Chancellor may hold office for a term of five years from the date on which he enters upon his office or until he attains the age of Seventy years whichever is earlier, and shall, on the expiration of his term of office, be ineligible for reappointment to the office:

Provided, that the Vice-Chancellor shall, notwithstanding the expiration of his term, continue to hold his office until his successor is appointed and enter upon his office up to a maximum period of one year.

**Authorities of
the University**

15. The authorities of the University shall be the Senate, the Syndicate, the Academic Council, the Schools of Studies, the Finance Committee and such other authorities as may be declared by the Statutes to be authorities of the University:

Provided that the constitution, power and functions of such other authorities as may be declared to be authorities of the University, shall be as prescribed by the Statutes.

Statutes

20. Subject to the provisions of this Act, the Statutes may provide for all or any of the following matters, namely -

- (a) the constitution, powers and duties of the authorities and other bodies of the University, the qualifications and disqualifications for membership of such authorities and other bodies, appointment and removal of members thereof and other matters connected therewith;
- (b) the appointment, powers and duties of the officers of the University in so far as they are not provided for in the Act;
- (c) the appointment, terms and conditions of service and the powers and duties of the employees of the University;
- (d) the terms and conditions under which institutions may be associated with the University;
- (e) the administration of the University; the establishment and abolition of colleges, institution and hostels; the grant and withdrawal of affiliation or recognition to colleges, hostels and other institutions not maintained by the University; the institution of Fellowship, Scholarships, Awards and the like; the conferment of degrees and other academic distinctions and the grant of diplomas and certificates; and the maintenance of the register of Registered Graduates of the University; and
- (f) any other matter which is necessary for the proper and effective management and conduct of the affairs of the University and which by this Act is to be or may be prescribed by the Statutes.

How Statutes are made

21. (1) The first Statutes are those set out in the Second Schedule to this Act.
- (2) The Syndicate may, from time to time, make new or additional Statutes or may amend or repeal the Statutes in the manner provided hereafter in this section:

Provided that the Syndicate shall not make any Statute or any amendment of a Statute affecting the status, power or constitution of any existing authority of the University until such authority has been given an opportunity of expressing an opinion on the proposal, and any opinion so expressed shall be in writing and shall be considered by the Syndicate:

Provided further that no Statute shall be made by the Syndicate affecting the discipline of students, and standard of instruction, education and examination except after consulting with the Academic Council.

- (3) Every new Statute or addition to the Statutes or any amendment or repeal of a Statute shall require the approval of the Chancellor who may assent thereto or withhold assent or remit to the Syndicate for reconsideration.
- (4) A new Statute or a Statute amending or repealing an existing Statute shall have no validity unless it has been assented to by the Chancellor.

Aims and Objectives

The University shall :

- (i) foster the composite culture of India and establish such departments or institutions as may be required for the study and development of languages, scientific knowledge, arts and culture of India, and in particular those of the north-eastern region of the country;
- (ii) take special measures to facilitate students and teachers from all over India to join the University and participate in its academic programmes;
- (iii) promote in the students and teachers an awareness and understanding of the social needs of the country, and of the north-eastern region of India in particular, and prepare them for fulfilling such needs;
- (iv) make special provision for integrated courses in humanities, science and technology in the educational programmes of the University;
- (v) take appropriate measures for promoting inter-disciplinary studies in the University;
- (vi) establish such departments or institutions as may be necessary for the study of languages, literature and life of foreign countries with a view to inculcating in the students a world perspective; and international understanding; and
- (vii) promote a spirit of humanism, of tolerance, of social justice and the fellowship of faiths, of reason and a spirit of free enquiry in the search of truth, and a scientific approach to the problems of society.

THE STATUTE OF THE UNIVERSITY**Definitions****1. In these Statutes -**

- (i) "Act" means the Dhanamanjuri University Act, 2017;
- (ii) "Department" means a Department of Studies and includes a Division or a Centre of Studies established by the Ordinances;
- (iii) All words and expressions used herein and defined in the Act shall have the meanings respectively assigned to them in the Act.

**Vice -
Chancellor****2. (i) The emoluments and terms and conditions of service of the Vice-Chancellor shall be as follows:-**

- (a) There shall be paid to the Vice-Chancellor a salary as per UGC guidelines and he shall be entitled, without payment of rent, to use a furnished residence throughout his term of office and no charge shall fall on the Vice-Chancellor personally in respect of the maintenance of such residence.
- (b) The Vice-Chancellor shall be entitled to such retirement benefits as may be prescribed by the Government.
- (c) The Vice-Chancellor shall be entitled to travelling allowances at such rates as may be fixed by the Syndicate.
- (d) The Vice-Chancellor shall be entitled to leave on full pay for one-eleventh of the period spent by him on active service.
- (e) The Vice-Chancellor shall also be entitled, on medical grounds or otherwise, to leave without pay for a period not exceeding three months during the term of his office:

Provided that such leave may be converted into leave on full pay to the extent to which he will be entitled to leave under sub-clause (d).

- (ii) Notwithstanding anything contained in clause (i), the Syndicate may, with the previous approval of the Chancellor, vary the emoluments and all or any of the conditions of service of the Vice-Chancellor at the time of his appointment.
- (iii) If the Office of the Vice-Chancellor becomes vacant, the functions of this Office shall, until some person is appointed under Section 14 of the Act to the vacant office, be performed by the Pro Vice-Chancellor.

Provided that in the absence of the Pro Vice-Chancellor, the senior most Dean in station, in consultation with all the Deans, shall carry out the current duties of the Vice-Chancellor, and if there is no Pro Vice-

Chancellor and the senior most Dean is not able to act, the Registrar shall carry out the current duties of the Vice-Chancellor and call a meeting of the Syndicate forthwith and take its directions for carrying on of the work of the University.

**Powers and duties
of
Vice-Chancellor**

3. (i) The Vice-Chancellor shall have a general responsibility for maintaining and promoting the efficiency and good order of the University.
- (ii) It shall be the duty of the Vice-Chancellor to see that the provisions of the Act, these Statutes, the Ordinances and the Regulations are duly observed and the decision taken by the authorities of the University are implemented.
- (iii) The Vice-Chancellor shall have power to convene meetings of the Senate, the Syndicate and the Academic Council and shall perform all such acts as may be necessary to carry out the provisions of the Act, these Statutes and the Ordinances.
- (iv) The Vice-Chancellor shall be entitled to be present at and to address any meeting of any authority or body or committee of the University but shall not be entitled to vote thereat unless he is a member of such authority or body or committee.
- (v) If, in the opinion of the Vice-Chancellor, any emergency has arisen which requires immediate action to be taken, the Vice-Chancellor shall take such action as he deems necessary and shall report the same for approval at the next meeting to the authority which, in the ordinary course, would have dealt with the matter:

Provided that if the action taken by the Vice-Chancellor is not approved by the authority concerned, he may refer the matter to the Chancellor, whose decision thereon shall be final:

Provided further that where any such action taken by the Vice-Chancellor affects any person in the service of the University, such person shall be entitled to prefer, within thirty days from the date on which he receives notice of such action, an appeal to the Syndicate.

- (vi) The Vice-Chancellor shall exercise such other powers as may be prescribed by the Ordinances or the Regulations.
- (vii) Notwithstanding anything contained in these Statutes, the Vice-Chancellor may not act upon any decision of any authority, if he is of the opinion that it is *ultra vires* of the provision of the Act, or Statutes or the Ordinances of the University. He may also not act upon any decision of any authority of the University, if he is of the opinion that such a decision is not in the interest of the University. In both the cases, he may ask the authority concerned to review the decision, and if difference in perceptions of the nature and impact of a decision persists, the matter shall be referred to the Chancellor, whose decision shall be final.

4. (i) The Pro Vice-Chancellor shall be appointed by the Syndicate on the recommendation of the Vice-Chancellor on such terms and conditions as may be laid down in the Ordinances:

Provided that where the recommendation of the Vice-Chancellor is not accepted by the Syndicate, the matter shall be referred to the Chancellor who may either appoint the person recommended by the Vice-Chancellor or ask the Vice-Chancellor to recommend another person to the Syndicate:

Provided further that the Syndicate may, on the recommendation of the Vice-Chancellor, appoint a professor to discharge the duties of a Pro Vice-Chancellor in addition to his own duties as a professor.

- (ii) The term of office of the Pro Vice-Chancellor shall be such as may be decided by the Syndicate but it shall not in any case exceed five years or until the expiration of the term of office of the Vice-Chancellor whichever is earlier and shall be eligible for re-appointment:

Provided that the Pro Vice-Chancellor shall retire on attaining the age of 65 years.

- (iii) The emoluments and other terms and conditions of service of the Pro Vice-Chancellor shall be such as may be prescribed by the Ordinances.

**Powers and
duties of Pro
Vice-
Chancellor**

5. (i) The Pro Vice-Chancellor shall assist the Vice-Chancellor in respect of such matters as may be specified by the Vice-Chancellor in this behalf. He shall also exercise such powers and perform such duties as may be delegated to him by the Vice-Chancellor.

- (ii) Where the Vice-Chancellor is the Chairman of any body or committee of the University and he is absent for any reason whatsoever from any meeting of such body or committee, the Pro Vice-Chancellor, shall preside over such meeting.

- (iii) A Pro Vice-Chancellor shall, on being authorised by the Vice-Chancellor in that behalf, be entitled to be present at and to address any meeting of any authority, body or committee of the University but shall not be entitled to vote thereat:

Provided that if the Pro Vice-Chancellor is a member of such authority, body or committee, such Pro Vice-Chancellor shall have all the rights and privileges of a member thereof.

**Dean of
School of
Studies**

6. (i) Every Dean of a School of Studies shall be appointed by the Vice-Chancellor from amongst the Professors of the School for a period not exceeding three years, and he shall be eligible for re-appointment:

Provided that where in any School, there is no Professor, the Vice-Chancellor may appoint one of the Associate Professors as the Dean of the School, till a Professor is appointed:

Provided further that if the Professor appointed as Dean of the School shall hold the Office for the duration of appointment from the date of his appointment as Dean, unless he ceases to be a member of the staff or resigns from the Deanship.

(ii) The Dean shall be the Head of the School of Studies and shall be responsible for the conduct and standard of teaching and research in the School. He shall have such other functions as may be prescribed by the Ordinances.

(iii) The Dean shall have right to be present and to speak at any meeting of a board or committee of the School, as the case may be, but not the right to vote thereat unless he is a member thereof.

Registrar

7. (i) The Registrar shall be appointed by the Syndicate and shall be a whole-time salaried officer of the University.

(ii) When the office of the Registrar is vacant or when the Registrar is, by reason of illness or absence for any other cause, unable to perform the duties of his office, the duties of the office shall be performed by such person as the Vice-Chancellor may appoint for the purpose.

(iii) The Registrar shall not by reason only of his being Secretary of the Senate, the Syndicate and the Academic Council, be deemed to be a member of any of these authorities.

(iv) The Registrar shall -

(a) be the custodian of the records, the common seal and such other properties of the University as the Syndicate shall commit to his charge;

(b) conduct the official correspondence of the Senate, the Syndicate and the Academic Council;

(c) supply to the Chancellor the copies of the agenda of the meetings of the authorities of the University as soon as they are issued and the minutes of the meetings of the authorities originally within a month of the holding of the meetings;

(d) in an emergency, when the Vice-Chancellor, or any of the Pro Vice-Chancellors, or the seniormost Dean in station is not able to act, call a meeting of the Syndicate forthwith and take its directions for carrying on the work of the University;

(e) represent the University in suits or proceedings by or against the University, sign powers of attorney and verify pleadings or depute his representative for the purpose; and

(f) perform such other duties as may be specified in these Statutes, or prescribed by the Ordinances or the Regulations or as may be required, from time to time, by the Syndicate or the Vice-Chancellor.

- (v) (a) The Registrar, or in relation to the Accounts and Audit staff of the University, the Finance Officer shall have power to take disciplinary action against the employees belonging to the ministerial staff and to suspend them pending inquiry, to administer warnings to them or to impose on them the penalty of censure or the withholding of increment:

Provided that no such penalty shall be imposed unless the person concerned has been given a reasonable opportunity of showing cause against the action proposed to be taken against him/her.

- (b) An appeal shall lie to the Vice-Chancellor against any order of the Registrar, or as the case may be, the Finance Officer, imposing the penalty of the withholding of increment.
- (c) In case where the inquiry discloses that a punishment beyond the powers of the Registrar, or, as the case may be, the Finance Officer is called for, the Registrar, or, as the case may be, the Finance Officer shall, upon conclusion of the inquiry, make a report to the Vice-Chancellor along with his recommendations, for such action as the Vice-Chancellor might deem fit:

Provided, that an appeal shall lie to the Syndicate against the order of the Vice-Chancellor imposing the penalty of dismissal.

- Finance Officer** 8. (i) The Finance Officer shall be appointed by the Syndicate and shall be a whole-time salaried Officer of the University.
- (ii) When the office of the Finance Officer is vacant or when the Finance Officer is, by reason of illness or absence for any other cause, unable to perform the duties of his office, the duties of the office shall be performed by such person as the Vice-Chancellor may appoint for the purpose.
- (iii) The Finance Officer shall -
- (a) exercise general supervision over the funds of the University and shall advise as regard to its financial policy ; and
 - (b) perform such other financial functions as may be assigned to him by the Syndicate or as may be prescribed by these Statutes or the Ordinances :
- Provided that the Finance Officer shall not incur any expenditure or make any investment exceeding such amount as may be prescribed without the previous approval of the Syndicate.
- (iv) Subject to the control of the Syndicate, the Finance Officer shall -
- (a) hold and manage the property and investments including trust and endowed property for furthering any of the objects of the University;
 - (b) see that the limits fixed by the Finance Committee for recurring and non-recurring expenditure for a year are not exceeded and that all money are expended for the purposes for which they are granted or allotted;

- (c) be responsible for the preparation of annual accounts and the budget of the University for the next financial year and for their presentation to the Syndicate ;
 - (d) keep a constant watch on the state of the cash and bank balances and on the state of investments ;
 - (e) watch the progress of collection of revenue and advise on the methods of collection employed ;
 - (f) have the accounts of the University regularly audited by an internal audit party ;
 - (g) see that the registers of buildings, land, furniture and equipment are maintained up-to-date and that the stock checking is conducted of equipment and other consumable materials in all offices, Special Centres, Specialised Laboratories, colleges and institutions maintained by the University;
 - (h) call for explanation for unauthorised expenditure and for other financial irregularities and suggest disciplinary action against the persons at fault; and
 - (i) call for from any office or college or institution under the University any information or returns that he may consider necessary for the discharge of his financial responsibilities.
- (v) The receipt of the Finance Officer or of the person or persons duly authorized in this behalf by the Syndicate for any money payable to the University shall be sufficient discharge for the same.

**Officers of the
University**

9. (i) The following shall be the Officers of the University, namely:-

- a. Vice Chancellor
- b. Pro Vice-Chancellor
- c. Dean of School of Studies
- d. Registrar
- e. Director, College Development Council
- f. Librarian
- g. Finance Officer
- h. Controller of Examinations
- i. Dean of Students
- j. Proctor
- k. University Engineer
- l. Any other officers as may be prescribed.

- (ii) (a) The Dean of Students shall be appointed from amongst the teachers of the University not below the rank of Associate Professor by the Syndicate on the recommendation of the Vice Chancellor. The Dean so appointed shall be a whole-time officer and shall hold office for a term of three years and shall be eligible for re-appointment:

Provided that the Syndicate may, if it is considered necessary, appoint, on the recommendation of the Vice-Chancellor, a teacher, not below the rank of Associate Professor to discharge the duties of the Dean of Students in addition to his duties, and in such a case the Syndicate may sanction a suitable allowance.

- (b) The person who is appointed as the Dean of Students shall continue to hold his lien on his substantive post and shall be eligible to all the benefits that would have otherwise accrued to him but for his appointment as the Dean of Students.
- (c) When the office of the Dean of Students is vacant or when the Dean of Students is, by reasons of illness or absence for any other cause, unable to perform the duties of his office, the duties of the office shall be performed by such persons as the Vice-Chancellor may appoint for the purpose.
- (d) The Duties and powers of the Dean of Students shall be prescribed by the Ordinances.

Proctor

- (iii) (a) The Proctor shall be appointed by the Syndicate on the recommendation of the Vice-Chancellor and shall exercise such powers and perform such duties in respect of the maintenance of discipline among the students as may be assigned to him by the Vice-Chancellor.
- (b) The Proctor shall hold office for a term of two years and shall be eligible for re-appointment.

Librarian

- (iv) (a) The Librarian shall be appointed by the Syndicate and shall be a whole-time salaried officer of the University.
- (b) The duties and powers of the Librarian shall be regulated by the Ordinances.

Controller of Examination

- (v) (a) The Controller of Examinations, the Director, College Development Council, and the University Engineer shall be appointed by the Syndicate and shall be whole-time salaried officers of the University.
- (b) The duties and powers of the Controller of Examinations, the Director, College Development Council and the University Engineer shall be regulated by the Ordinances.

- Senate 10. (i) Senate shall consist of the following members, namely:-

Ex-Officio Members

- a. The Chancellor;
- b. The Vice-Chancellor;
- c. The Pro Vice-Chancellor, if any;
- d. The remaining members of the Syndicate;
- e. The Dean of Students;
- f. The Proctor, if any;
- g. The Registrar;
- h. The Finance Officer;
- i. One Warden, by rotation;
- j. The Librarian;
- k. The Controller of Examinations;
- l. Representatives of the Government of any other State or States or Union Territories, if any, to which the jurisdiction of the University may extend;
- m. The Secretary, Higher and Technical Education, Govt. of Manipur;
- n. The Director of University & Higher Education, Govt. of Manipur;
- o. The Controller of Technical Education, Govt. of Manipur;
- p. The Director of Medical & Health Services, Govt. of Manipur;
- q. The Director of Agriculture, Govt. of Manipur;
- r. The Director of Veterinary & Animal Husbandry, Govt. of Manipur;
- s. The Director of Fisheries, Govt. of Manipur;
- t. The Director of Commerce & Industries, Govt. of Manipur;
- u. The Principal Chief Conservator of Forest, Govt. of Manipur;
- v. The Chairman, Council of Higher Secondary Education, Manipur;
- w. The Chairman, Board of Secondary Education Manipur;
- x. The Director of Youth Affairs and Sports, Govt. of Manipur;
- y. The Director of Arts & Culture, Govt. of Manipur;
- z. The Director of Social Welfare, Govt. of Manipur;
- aa. The Director of Tribal Affairs & Hills, Govt. of Manipur;

Other Members

- bb. All Deans of Schools of Studies;
- cc. All Heads of Centres /Departments who are not Deans;
- dd. Professors, one Associate Professor and one Assistant Professor from each School of Studies, who are members of the Academic Council under Statute 14 (i) (j);

- ee. Seven Principals of affiliated degree colleges of Arts, Science and Commerce including two colleges from the rural areas and two colleges from the hill areas and two colleges in Imphal and at least one college affiliated upto honours standard in not less than four science subjects, by rotation in order of seniority;
 - ff. All Principals of Medical, Veterinary, Agricultural, Engineering, Dance, Music, Arts and Law Colleges affiliated to the University;
 - gg. Not more than two Heads of other institutions, if any, recognized by the University, by rotation in order of seniority;
 - hh. Six teachers of affiliated degree colleges including one Associate Professor each from among colleges in rural areas, colleges in hill areas and colleges in Imphal, by rotation in order of seniority:
 Provided that not more than one teacher shall come from one and the same college.
 - ii. One Professor each from professional colleges, by rotation in order of seniority;
 - jj. Four teachers from professional colleges including two Associate Professors and two Assistant Professors by rotation in order of seniority, provided that ordinarily not more than one teacher shall come from one and the same college;
 - kk. All members of Parliament from Manipur;
 - ll. Five members of the Manipur Legislative Assembly of whom at least two shall be from the hill districts to be nominated by the Speaker of the Assembly;
 - mm. Persons not exceeding ten in number nominated by the Chancellor from amongst the donors each of whom has contributed a sum of Rs. 10,00,000/- or more to the University;
 - nn. Ten persons distinguished in Literature, Arts, Law, Medicine, Engineering, Industry, Technology, Labour, Commerce, Agriculture and Public life to be nominated by the Chancellor;
 - oo. Not more than three persons to be nominated by the Chancellor from amongst those whose interests are not otherwise represented:
 Provided that one of these shall be a woman:
 Provided further that no employee of the University or of an affiliated institution shall be eligible for nomination under sub-clauses (nn) and (oo);
- (ii) If anybody or persons entitled to elect members fails to do so within the time prescribed by the Senate, the Senate may appoint as a member any person whom that body of persons could have elected as a member:
 Provided that in the case of the first election to the Senate, the powers conferred upon the Senate by this clause shall be exercisable by the Syndicate.

- (iii) Save as otherwise expressly provided and except the ex-officio members, all other members shall hold office for a period of three years:

Provided that no person nominated or elected in his capacity as a member of a particular body or as a holder of a particular appointment shall be a member after he ceases to be a member of the body or holder of that appointment as the case may be.

- (iv) When a person ceases to be member of the Senate he shall cease to be a member of any of the authorities of the University of which he may happen to be a member by virtue of his membership of the Senate.
- (v) One-third of the members of the Senate shall form the quorum:

**Meeting of the
Senate**

11. (i) An annual meeting of the Senate shall be held on a date fixed by the Syndicate and at such annual meetings a report of the proceedings of the Syndicate and a report of the working of the University during the previous year together with a statement of the receipts and expenditure, the balance-sheet as audited and the budget for the next financial year shall be presented by the Syndicate and any vacancies among the officers of the University or among the members of the Senate or the Syndicate which ought to be filled by the Senate shall also be filled up.
- (ii) A copy each of the reports together with a copy of the statement of receipts and expenditure and of the balance-sheet and the budget referred to in clause (i) shall be sent to every member of the Senate at least seven days before the date of the annual meeting.

Syndicate

12. (i) The Syndicate shall consist of the following members, namely:-
- a. The Vice-Chancellor, ex-officio;
 - b. The Pro Vice-Chancellor, if any, ex-officio;
 - c. The Administrative Secretary of Higher Education, Manipur or his nominee;
 - d. Three Deans of Schools of Studies, of whom two shall be from Group I and one from Group II; and once their term as Dean is over, two shall be from Group II and one from Group I, by rotation, according to seniority. Group I and Group II shall comprise the following:

GROUP I

School of Social Science;

School of Humanities;

School of Law;

School of Commerce; and

School of Performing and Fine Arts.

GROUP II

School of Life Sciences;
 School of Human and Environmental Sciences;
 School of Medical Sciences;
 School of Mathematical and Physical Sciences;
 School of Engineering;
 School of Agriculture and Agronomy; and
 Any other schools as may be established later.

- e. The Dean of Students, ex-officio;
 - f. Four persons to be nominated by the Chancellor;
 - g. Three Heads of Departments, nominated by the Chancellor, on the recommendation of the Vice-Chancellor;
 - h. Three teachers of the University, nominated by the Chancellor, on the recommendation of the Vice-Chancellor;
 - i. Three members of the Senate nominated by the Chancellor, none of whom shall be an employee of the University or an institution affiliated to, or associated with the University;
 - j. Three Heads of Constituent colleges, affiliated colleges, and other institutions associated with the University of whom, at least, one shall be the Head of a Women's College, nominated by the Chancellor; and
 - k. The Director of University and Higher Education, Manipur or his nominee.
- (ii) The members of the Syndicate shall hold office for a term of three years:
- Provided that the members referred to in items (g), (h), (i) and (j) of clause (i) shall cease to be members of the Syndicate when they cease to be Heads of Departments, Centres, Teachers, Members of the Senate and Heads of Colleges / Institutions, respectively.
- (iii) The term of office of the members of the Syndicate shall commence from the date of appointment, or nomination as the case may be.
- (iv) Ten members of the Syndicate shall form the quorum.

Power of the Syndicate

13. Subject to the provisions of the Act, these Statutes and Ordinances, the Syndicate shall, in addition to any other powers vested in it, have the following powers, namely:-

- (i) to appoint such Professors, Associate Professors, Assistant Professors, and other members of the teaching staff as may be necessary, on the recommendations of the Selection Committees constituted for the purpose, and to provide for filling temporary vacancies therein;
- (ii) to fix the emoluments and define the duties and conditions of service of Professors, Associate Professors, Assistant Professors, and other members of the teaching staff:

Provided that no action shall be taken by the Syndicate in respect of the number, the qualifications and the emoluments of teachers otherwise than after consideration of the recommendations of the Academic Council;

- (iii) to create administrative, ministerial and other necessary posts and to make appointments thereto;
- (iv) to regulate and enforce discipline among the members of the teaching, administrative and ministerial staff of the University in accordance with these Statutes and the Ordinances;
- (v) to manage and regulate the finances, accounts, investments, property, business and all other administrative affairs of the University and, for that purpose to appoint such agents as it may think fit;
- (vi) to invest any money belonging to the University, including any unapplied income in such stocks, funds, shares or securities, as it shall, from time to time, think fit, or in the purchase of immovable property in India with the like powers of varying such investments from time to time;
- (vii) (a) to accept on behalf of the University any trust, bequest, donation or transfer of any movable or immovable property to the University; and
(b) to transfer any movable or immovable property on behalf of the University;
- (viii) to provide the buildings, premises, furniture, apparatus and other means needed for carrying on the work of the University;
- (ix) to enter into, vary, carry out and cancel contracts on behalf of the University;
- (x) to entertain, adjudicate upon, and if it thinks fit, to redress, any grievances of the salaried officers, the teaching staff and other employees of the University who may for any reasons feel aggrieved:

Provided that in matters of discipline and punishment, where the final power has been vested in the Vice-Chancellor or any other officer of the University, no appeal shall lie to the Syndicate;

- (xi) to appoint examiners and moderators and, if necessary, to remove them, and to fix their fees, emoluments and travelling and other allowances after consulting with the Academic Council;
- (xii) to select a common seal for the University and provide for the custody and use of the seal;
- (xiii) to institute Fellowships, Scholarships, Studentships, Medals and Prizes; and
- (xiv) to delegate any of its powers to the Vice-Chancellor, the Registrar or such other officer of the University or to a Committee appointed by it as it may deem fit.

**Academic
Council**

14. (i) The Academic Council shall consist of the following members, namely:-

Ex-Officio Members

- a. The Vice-Chancellor;
- b. The Pro Vice-Chancellor, if any;
- c. The Deans of Schools of Studies;
- d. The Librarian;
- e. Heads of Departments/Centres;
- f. The Dean of Students;
- g. The Proctor;
- h. One Warden by rotation;

Other Members

- i. The Professors of the University;
- j. One Associate Professor and one Assistant Professor not covered under the preceding items from each School of Studies, by rotation in order of seniority within the School and in the respective categories;
- k. One student member from each level of study (i.e. MA/M Com/M Sc (Previous); MA/M Com/M Sc (Final); M Phil; Ph D of the University) elected from amongst the students of the University provided that he fulfils the eligibility conditions as laid down in Clause (v) of this Statute;
- l. Three Principals of professional colleges to be nominated by the Vice-Chancellor in consultation with the ex-officio members;
- m. Principals of constituent colleges;
- n. Three Principals of affiliated colleges to be co-opted by the Academic Council on the recommendations of the Vice-Chancellor for their special knowledge.

- (ii) All members of the Academic Council, other than ex-officio and student-members, shall hold office for a term of three years. The term of a student-member of the Academic Council shall be one year and no student-member would be eligible for re-election to the Council. The term of the members shall commence on such date as may be notified:

Provided that no student-member shall be a member of the Academic Council and the Board of the School simultaneously;

Provided further that the members referred to in item (k) of clause (i) shall cease to be members of the Academic Council when they cease to be students of the University;

- (iii) No members referred to in item (k) of clause (i) shall have the right to be present at the meeting of the Academic Council when it takes up for consideration of any of the following subjects:

- (a) Faculty positions, recruitment, conditions of service and academic freedom;
- (b) Actual process of evaluating academic performance and merits of students.

- (iv) Fifteen members of the Academic Council shall form the quorum.

- (v) The M Phil/Ph D students having 60 per cent marks at MA/M Com/M Sc level, or equivalent, and those admitted to Ph D programme directly will be eligible to seek election to the Academic Council, provided that their academic performance has been satisfactory. In the case of other students, i.e. MA/M Com/M Sc, those having 50 per cent marks in the previous examinations, or equivalent, will be eligible to seek election to the Academic Council, provided that their academic performance has been satisfactory.

**Powers and
duties of the
Academic
Council**

15. Subject to the provisions of the Act and these Statutes, the Academic Council shall, in addition to all other powers vested in it, have the following powers, duties and functions namely:-

- (i) to report of any matter referred to it by the Senate or the Syndicate;
- (ii) to make proposals to the Syndicate for the establishment of Departments, Colleges, Institutions of higher learning, Special Centres, Specialised Laboratories, Libraries and Museums;
- (iii) to formulate, modify or revise schemes for the organization of, and assignment of subjects to Schools of Studies;
- (iv) to consider proposals submitted by the Schools of Studies;
- (v) to promote research within the University and to require from time to time, reports on such research;
- (vi) to make recommendations to the Syndicate with regard to the creation and abolition of teaching posts in the University and the classification of the said posts and the emoluments and duties attaching thereto;

- (vii) to recognize diplomas and degrees of other Universities and institutions and to determine their equivalent diplomas and degrees of the Manipur University;
- (viii) to appoint Committees for admission to the University;
- (ix) to publish lists of prescribed or recommended text-books and to publish the syllabi of prescribed courses of study;
- (x) to make such arrangements for the instructions and examination of persons, not being members of the University, as may be necessary;
- (xi) to recommend to the Syndicate draft Ordinances regarding examinations of the University and the conditions on which students should be admitted to such examinations;
- (xii) to make recommendations to the Syndicate in regard to the appointment of examiners and, if necessary, their removal and fixations of their fees, emoluments and travelling and other expenses;
- (xiii) to make arrangements for the conduct of examinations and to fix dates for holding them;
- (xiv) to declare the results of various University examinations, or to appoint Committees or Officers to do so;
- (xv) to make recommendations for the conferment of honorary degrees and to confer or grant degrees, academic distinctions, honours, diplomas, licenses, titles and marks of honour;
- (xvi) to make proposals to the Syndicate for the institution of fellowships, scholarships, studentships, medals and prizes and to award the same;

Planning Board

16. (i) The Vice-Chancellor shall be the Chairman of the Planning Board and other members of the Board shall be appointed by the Chancellor and shall hold office for such period as he may determine.
- (ii) The Planning Board shall, in addition to all other powers vested in it by the Act have the right to advise the Syndicate and the Academic Council on any academic matter.

Schools of Studies

17. (i) The University shall have such Schools of Studies as may be specified in the Ordinances.
- (ii) (a) Every School of Studies (hereinafter referred to as the School) shall consist of such Departments as may be assigned to it by the Ordinances.
- (b) Each Department shall consist of the following members, namely:-
- (i) Teachers of the Department;
 - (ii) Persons appointed to conduct research in the Department;
 - (iii) Honorary Professors, if any, attached to the Department;
 - (iv) Such other persons as may be members of the Department in accordance with the provisions of the Ordinances.

- (c) (i) Each Department shall have a Head who shall be appointed by the Syndicate from amongst the Professors, for a period not exceeding two years by rotation;

Provided that where in any Department there is only one Professor, or there is no Professor, the Syndicate may also appoint one of the Associate Professors as the Head of the Department for a period not exceeding two years:

Provided further that the person appointed as the Head of the Department shall hold the office for duration of appointment from the date he is appointed as Head, unless he ceases to be a member of the staff or resigns the Headship.

- (ii) The duties and functions of a Head of the Department shall be as prescribed by the Ordinances.

- (iii) Every School shall have a Board consisting of the following members, namely:-

- (a) The Dean of the School, ex-officio;
- (b) The Heads of the Departments in the School, ex-officio;
- (c) The Professors in the Departments of the School, ex-officio;
- (d) One Associate Professor, and One Assistant Professor, by rotation, according to seniority, from each Department in the School;
- (e) Not more than five members nominated by the Academic Council for their special knowledge in any subject assigned to the School or in any allied branch of knowledge, and who are not employees of the University or any of its recognised institutions;
- (f) Such other members, but not exceeding five, as may specified in the Ordinances;
- (g) One student member from each year of study [i.e. M.A./M.Sc. (Previous), M.A./M.Sc. (Final), M. Phil., Ph.D.] of the School elected from amongst the students of the School, provided that he fulfils the eligibility conditions as laid down in Statute 17(vii) and provided further that they shall not have the right to be present when any of the following subjects are taken up for consideration by the Board:
 - a) Faculty positions, recruitment, conditions of service and academic freedom, and
 - (b) Actual process of evaluating academic performance and merit of students.

- (iv) All members of a Board other than ex-officio members and student members, shall hold office for a term of three years. The term of student-members on the Board shall, however, be for a period of one year and no student-member shall be eligible for re-election to the Board. The term of members shall commence on such date as may be notified.
- (v) Every Board shall have such powers and shall perform such duties as may be prescribed by the Ordinances.
- (vi) The conduct of the meetings of a Board and the quorum required shall be prescribed by the Ordinances.
- (vii) Students having minimum 60 per cent marks in their previous examination and those admitted directly to Ph. D. programme, will be eligible to seek election to the Board of the School, provided that their academic performance has been satisfactory.

**Finance
Committee**

18. (i) The Finance Committee shall consist of the following members, namely:-
- a. The Vice-Chancellor (ex-officio);
 - b. The Administrative Secretary (Finance), Govt. of Manipur (ex-officio);
 - c. One person, nominated by the Chancellor;
 - d. Three persons, who are not employees of the University or of any affiliated institution nominated by the Syndicate.
- (ii) The Finance Officer shall be the Secretary of the Finance Committee.
 - (iii) Three members of the Finance Committee shall form the quorum.
 - (iv) All members of the Finance Committee, other than ex-officio members, shall hold office for a term of three years.
 - (v) The Vice-Chancellor shall preside at the meetings of the Finance Committee.
 - (vi) The Finance Committee shall meet at least twice every year to examine the accounts and scrutinize proposals for expenditure.
 - (vii) The annual accounts and financial estimates of the university prepared by the Finance Officer shall be laid before the Finance Committee for consideration and comments and thereafter submitted to the Syndicate for approval with or without amendments.

**Board or
Committees**

19. The Senate, the Syndicate or the Academic Council may appoint Boards or Committees consisting of members of the authority making such appointment and of such other persons (if any) as that authority in each case may think fit; and any such Board or Committee may deal with any subject assigned to it subject to subsequent confirmation by the authority which appoint it.

**Withdrawal
of degrees**

25. The Academic Council may, by a special resolution passed by a majority of not less than two-thirds of the members present and a voting, withdraw any degree or academic distinction conferred on, or any certificate or diploma granted to, any person by the University for good and sufficient cause:

Provided that no such resolution shall be passed until a notice in writing has been given to that person calling upon him to show cause within such time as may be specified in the notice why such resolution should not be passed and until his objections, if any, and any evidence he may produce in support of them, have been considered by the Academic Council.

**University
Teachers**

26. (i) Teachers of the University shall be of two classes, namely:-
 (a) Appointed teachers of the University;
 (b) Recognised teachers of the University.
- (ii) Appointed teachers of the University shall be either –
 (a) employees of the University paid by the University and appointed by the Syndicate as Professors of Eminence, Professors, Associate Professors or Assistant Professors or otherwise as teachers of the University, or
 (b) persons appointed by the Syndicate as Honorary Professors, Emeritus Professors, Associate Professors or Assistant Professors or otherwise as teachers of the University.
- (iii) Recognized teachers of the University shall be the members of the staff of a recognized institution other than an institution maintained by the University:

Provided that no such member of the staff shall be deemed to be a recognized teacher unless he is recognized by the Syndicate as a Professor, Associate Professor or in any other capacity as a teacher of the recognized institution.

- (iv) The qualifications of recognized teachers of the University shall be such as may be prescribed by the Ordinance.
- (v) All applications for the recognition of teachers of the University shall be made in such a manner as may be laid down by the Regulations made by the Syndicate in that behalf.
- (vi) The period of recognition of a teacher of the University as Professor or Associate Professor shall be determined by Ordinances made in that behalf. A person in the service of a recognized institution, recognized as a teacher of the University otherwise than as a Professor or Associate Professor shall continue to be recognized so long as he is in the service of the institution.

- (vii) The Academic Council may, by a special resolution passed by a majority of not less than two-thirds of the members present and voting, withdraw recognition from a teacher:

Provided that no such resolution shall be passed until a notice in writing has been given to that person calling upon him to show cause within such a time as may be specified in the notice why such resolution should not be passed and until his objections, if any, evidences he may produce in support of them have been considered by the Academic Council.

- (viii) A person aggrieved by an order of withdrawal under clause (vii) may, within three months from the communication to him of such order, appeal to the Syndicate who may pass such orders thereon as he thinks fit.
- (ix) No person shall be appointed or recognized as a teacher of the University except on the recommendation of a Selection Committee constituted for the purpose.

**Selection
Committee
of Teachers**

- 27. (i) There shall be Selection Committees for making recommendations to the Syndicate for appointments to the posts of Professors, Associate Professors and Assistant Professors.
- (ii) The Selection Committees shall be as follows:
 - (a) For Assistant Professor and Associate Professor -
 - (i) The Vice-Chancellor, in his absence, the Pro Vice-Chancellor, as the Chairman of the Selection Committee;
 - (ii) One nominee of the Chancellor;
 - (iii) The Head of the Department concerned;
 - (iv) Three outside experts in the subject to be invited out of the list approved by the Syndicate.

The quorum shall be four, of which at least two outside subject-experts should be present.

- (b) For Professor -
 - (i) The Vice-Chancellor, in his absence, the Pro Vice-Chancellor, as the Chairman of the Selection Committee;
 - (ii) One nominee of the Chancellor;
 - (iii) The Head of the Department concerned;
 - (iv) Three outside experts in the subject to be invited out of the list approved by the Syndicate.

At least five members, where the University has a Pro Vice-Chancellor, or four members otherwise, including two outside experts shall constitute the quorum. Both the Vice-Chancellor and the Pro Vice-Chancellor are members.

Weightage should be given to the experts' opinion.

- (iii) The procedure to be followed by a Selection Committee in making recommendations shall be laid down in the Ordinances.
 - (iv) If the Selection Committee recommends to the Syndicate the name of one person only and that person is not acceptable to the Syndicate, the Syndicate shall record its reasons in writing for not accepting the recommendation and direct the Registrar to advertise the vacancy again and convene a meeting of the Selection Committee for making fresh recommendations, and in so doing, communicate to every member of the Selection Committee the reason recorded above.
 - (v) If the Syndicate is unable to accept any recommendation made by the Selection Committee, it may remit the same to the Selection Committee for reconsideration and if the difference is not resolved, the Syndicate shall record its reasons and submit the case to the Chancellor for orders.
 - (vi) Where an appointment is to be made to a temporary vacancy in the post of a teacher of the University, the appointment shall be made, if the vacancy is for a period of one and a half years or more, on the recommendation of the Selection Committee in accordance with the provisions of the preceding sub-clauses and no ad-hoc appointment shall be made by the Syndicate.
 - (vii) The constitution of the Selection Committee for the purpose of recognizing teachers shall be provided for by the Ordinance.
28. (i) There shall be Selection Committees for making recommendations to the Syndicate for appointment to the posts of the Registrar, Finance Officer, Controller of Examinations, Librarian, University Engineer and other posts above the grade of Section Officers.
- (ii) The Selection Committee shall be as follows:
- a. The Vice-Chancellor, in his absence, the Pro Vice-Chancellor (if any) as the Chairman of the Selection Committee;
 - b. One nominee of the Chancellor;
 - c. One member of the Syndicate to be nominated by it;
 - d. Three experts not holding any office of profit under the University to be nominated by the Syndicate.

At least four members shall constitute the quorum of the Selection Committee.

29. Notwithstanding anything contained in Statute 27, the Syndicate may invite a person of high academic distinction and professional attainment to accept a post of Professor or Associate Professor in the University, as the case may be, on such terms and conditions as it deems fit, and on the person agreeing to do so, appoint him to the post.

33. (i) Notwithstanding anything contained in the terms of his contract of service or of his appointment, an employee of the University, other than a teacher, may be removed by the authority which is competent to appoint the employee -

- (a) If he is of unsound mind ;
- (b) If he is an un-discharged insolvent;
- (c) If he has been convicted by a court of law of any offence involving moral turpitude and sentenced in respect thereof to imprisonment for not less than six months;
- (d) If he is, otherwise guilty of misconduct:

Provided that no officer of the University shall be removed from his office unless a resolution to that effect is passed by the Syndicate by a majority of two-thirds of its members present and voting.

- (ii) No such employee shall be removed under clause (i) until he has been given a reasonable opportunity of showing cause against the action proposed to be taken in regard to him.
- (iii) Where the removal of such employee is for a reason other than that specified in sub-clause (c) or sub-clause (d) of clause (i), he shall be given three months' notice in writing or paid three months salary in lieu of notice.
- (iv) Notwithstanding anything contained in these Statutes, an employee of the University, not being a teacher, shall be entitled to resign-
 - (a) in the case of a permanent employee, only after giving three months' notice in writing to the appointing authority or paying to the University three months' salary in lieu thereof;
 - (b) in any other case, only after giving one months' notice in writing to the appointing authority or paying to the University one months' salary in lieu thereof.

**Maintenance
of discipline
among
students of
the University**

34. (i) All powers relating to discipline and disciplinary action in relation to students shall vest in the Vice Chancellor.
- (ii) The Vice-Chancellor may delegate all or such of his powers as he deems proper to the Proctor and to such other persons as he may specify in this behalf.
- (iii) Without prejudice to the generality of his powers relating to the maintenance of discipline and taking such action in the interest of maintaining discipline as may seem to him appropriate, the Vice-Chancellor may in the exercise of his powers aforesaid, order or direct that any student or students be expelled from any college or institution maintained by the University, Department, Special Centre or Specialized Laboratory, or be, for a stated period rusticated or be not, for a stated period, admitted to a course or courses of study in any such College of Institution, Department, Special Centre or Specialized Laboratory, or be fined in a sum of rupees that may be specified, or be debarred from taking an examination or examinations for one or more years or that the results of the student or students concerned in the examination or examinations in which he has or they have appeared be cancelled.
- (iv) The Principals, or as the case may be, the Heads of the Colleges, Institutions, Departments, Special Centres or Specialized Laboratories shall have the authority to exercise all such disciplinary powers over the students in their respective Colleges, Institutions, Departments, Special Centres or Specialized Laboratories as may be necessary for the proper conduct of such Colleges, Institutions, Departments, Special Centres or Specialized Laboratories.
- (v) Without prejudice to the powers of the Vice-Chancellor and the Proctor as aforesaid, detailed rules of discipline and proper conduct shall be framed. The Principals or, as the case may be, the Heads of the Colleges, Institutions, Departments, Special Centres or Specialized Laboratories may frame such supplementary rules as they deem necessary for the aforesaid purposes. Every student shall provide himself with a copy of these rules.

Ordinance

35. Subject to the provisions of the Act and these Statutes, the Ordinances may provide for all or any of the following matters, namely:-
- a) the fees to be charged for courses of study in the University and for admission to the examinations, degrees and diplomas of the University;
 - b) the conditions of the award of fellowships, scholarships, studentships, exhibitions, medals and prizes;
 - c) the conduct of examinations, including the terms of office and manner of appointment and duties of examining bodies, examiners and moderators;
 - d) the maintenance of discipline among the students of the University;
 - e) the conditions of residence of students at the University;

- f) the special arrangements, if any, which may be made for the residence, discipline and teaching of women students and the prescribing for them of special courses of study;
- g) giving moral instruction;
- h) the numbers, qualifications, emoluments and the terms and conditions of service of teachers of the University;
- i) the management of colleges, institutions maintained by the University, Special Centres and Specialized Laboratories;
- j) supervision and inspection of colleges, recognized institutions, Special Centres and Specialized Laboratories;
- k) all other matters which by the Act or these Statutes are to be or may be provided for by the Ordinances;

**How
Ordinances
are made**

36. (i) The first Ordinances shall be made by the Vice-Chancellor with the previous approval of the Government of Manipur.
- (ii) The said Ordinances may be amended, repealed or added to at any time by the Syndicate provided that –
- (a) no Ordinance shall be made affecting the conditions of residence or discipline of students, except after consultation with the Academic Council.
 - (b) no Ordinance shall be made –
 - (i) affecting the admission or enrolment of students prescribing examinations, to be recognized as equivalent to the University examinations, or
 - (ii) affecting the conditions, mode of appointment or duties of examiners or the conduct or standard of examination or any course of study, unless a draft of such Ordinance has been proposed by the Academic Council.
- (iii) The Syndicate shall not have power to amend any draft proposed by the Academic Council but may reject the proposal or return the draft to the Academic Council for reconsideration, either in whole or in part, together with any amendments which the Syndicate may suggest.
- (iv) Where the Syndicate has rejected the draft of an Ordinance proposed by the Academic Council, the Academic Council may, within two months of the date of such rejection, appeal to the Chancellor and he may, by order, direct that the proposed Ordinances shall be laid before the next meeting of the Senate for its approval and that pending such approval, it shall have effect from such date as may be specified in the order:

Provided that if the Ordinance is not approved by the Senate at such meeting, it shall cease to have effect.

- (v) All Ordinances made by the Syndicate shall be submitted as soon as may be, to the Chancellor and the Senate, and shall be considered by the Senate at its next meeting; and the Senate shall have power, by a resolution passed by a majority of not less than two-thirds of the members present and voting, to cancel any Ordinance made by the Syndicate, and such Ordinance shall, from the date of such resolution, cease to have effect.
 - (vi) The Chancellor may by order, direct that the operation of any Ordinance shall be suspended until he has had an opportunity of exercising his power of disallowance and any order of suspension under this clause shall cease to have effect on the expiration of one month from the date of such order or on the expiration of fifteen days from the date of consideration of the Ordinance by the Senate, whichever period expires later.
 - (vii) The Chancellor, within three months after any Ordinance has been considered by the Senate, signify to the Syndicate his disallowance of the Ordinance, and from the date of receipt by the Syndicate of intimation of such disallowance, the Ordinance shall cease to have effect.
- Regulations** 37. (i) The authorities of the University may make Regulations consistent with this Act, these Statutes and the Ordinances –
- (a) laying down the procedure to be observed at their meetings and the number of members required to form a quorum;
 - (b) providing for all matters which by this Act, these Statutes or the Ordinances are to be prescribed by Regulations;
 - (c) providing for all other matters solely concerning such authorities or committees appointed by them and not provided for by this Act, these Statutes or the Ordinances.
- (ii) Every authority of the University shall make Regulations providing for the giving of notice to the member of such authority of the dates of meetings and of the business to be considered at meetings and for the keeping of a record of the proceedings of meetings.
- (iii) The Syndicate may direct the amendment in such manner as it may specify, of any Regulation made under this Statute, or the annulment of any such Regulation.
- Degrees / Diplomas** 38. (i) The University shall confer the following Degrees namely: –
- a. Doctor of Letters, Science and Laws;
 - b. Doctor of Philosophy;
 - c. Doctor of Medicine and Master of Surgery;
 - d. Master of Philosophy;
 - e. Master of Arts, Science, Commerce, Laws, Engineering, Technology, Agriculture Sciences, Veterinary & Animal Husbandry;

- f. Bachelor with or without Honours of Arts, Science, Commerce;
 - g. Bachelor of Medicine & Surgery, Engineering, Technology, Law, Agriculture Sciences, Veterinary & Animal Husbandry; and
 - h. Such other Bachelors' or Masters' Degree as may be prescribed by the Ordinances;
- (ii) The University shall award Diplomas and Certificates in such subjects as may be specified in the Ordinances.
- Recognised Institutions** 39. (i) The University shall maintain or affiliate or recognize or associate with it the following institutions, namely:-
- (a) Institutions maintained by the University;
 - (b) Institutions recognized by the University;
 - (c) Institutions associated with the University.
- (ii) Terms and conditions under which any institution may be recognized under clause (i) (b) shall be provided for by the Ordinances.
- Emoluments, Terms & Conditions of Service, etc. of Non-Teaching employees** 40. The Emoluments, Terms and Conditions of Service, and the Conduct Rules of the Non-teaching Employees of the University (other than the Registrar, Finance Officer, Librarian, Controller of Examination, Director, College Development Council and University Engineer) shall be those as may be prescribed by the Ordinances.
- Alumni Association** 41. Alumni Association:-
- (i) There shall be an Alumni Association for the University;
 - (ii) The powers and functions / duties of the Alumni shall be as may be specified in the Ordinance.
